NOTICE INVITING TENDER/REQUEST FOR PROPOSAL

The Embassy of India in Algiers (Algeria) invites proposal for supply of **vehicles** (on rental basis) to be used during high level visit during 10-16 October 2024, as per the list of items mentioned in paragraph (B) below.

(A) ELIGIBILITY CRITERIA :

1. Bidders should have technical, professional and practical experience of having provided similar services in the past, including to any of the other Diplomatic Missions.
2. Bidders may also submit, in brief, the history of their company with annual turn over. They may also furnish the certificate/license, if any, that may indicate their qualification for providing the equipments.
4. Bidders should ensure that the quotes should be provided to the Embassy by **1700 hrs on 9th Oct, 2024**.
5. To assist evaluation and comparison of the bids, the Embassy at its discretion, may ask the bidders for clarification on their bids. The clarifications and responses from the bidders shall be in writing.
6. If a bidder is asked to competitively quote for the same, the Embassy is not bound to accept the lowest quote or any tender, and reserves the right to accept the whole or any part of the tender and altering the numbers offered and the tenderer shall supply the same at the rate quoted.
7. Bidders should not have been barred / black-listed by the Governmental Department / Organization in India/Algeria or elsewhere (The bidder is requested to submit a self-declaration to this effect).
8. Bidders may submit their bids for providing the equipment in premises of the Embassy/Hotel Sheraton, Algiers.
